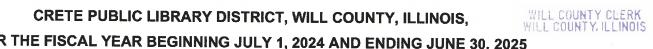

# ORDINANCE LEVYING AND ASSESSING TAXES OF THE

FOR THE FISCAL YEAR BEGINNING JULY 1, 2024 AND ENDING JUNE 30, 2025

**ORDINANCE NO. 24-04** 



BE IT ORDAINED by the Board of Library Trustees of the Crete Public Library District as follows:

SECTION 1: That the sum of TWO MILLION, ONE HUNDRED FIFTY-SIX THOUSAND, SIX HUNDRED AND EIGHTY-NINE DOLLARS (\$2,156,689) be and the same is assessed and levied from and against all taxable property within the limits of said Crete Public Library District as the same is assessed and equalized for state and county purposes for the current year 2024, in order to meet and defray all necessary expenses and liabilities of the District and are to be applied in liquidation of the appropriations heretofore made by Ordinance adopted by the Board of Library Trustees at a meeting thereof regularly convened and held on August 21, 2024 and duly published as provided by law [75 ILCS 16/30-85]. The amounts as required are itemized and needed for uses and purposes as follows, to wit:
