#### **ORDINANCE NO. 25-03**

ORDINANCE PROVIDING FOR BUDGET AND APPROPRIATION OF CRETE PUBLIC LIBRARY DISTRICT, WILL COUNTY, ILLINOIS FOR THE FISCAL YEAR BEGINNING JULY 1, 2025 AND ENDING JUNE 30, 2026

WHEREAS, the Board of Library Trustees of the Crete Public Library District, Will County, Illinois, caused to be prepared in tentative form a Budget and the Secretary of this Board has made the same conveniently available to public inspection for at least 30 days prior to final action thereon: and

WHEREAS, a public hearing is set to be held to such budget on the <u>16<sup>th</sup></u> day of <u>July</u>, 2025, and notice of said hearing was given at least thirty (30) days prior thereto as required by law, and all other legal requirements have been complied with:

**NOW THEREFORE**, Be it ordained by the Board of Library Trustees of the Crete Public Library District, Will County, Illinois as follows:

**SECTION 1**: That the fiscal year of this Public Library District is hereby fixed to begin on July 1, 2025 and end on June 30, 2026.

**SECTION 2**: That the following Budget containing an estimate of the amount available and expenditures and the appropriations contained therein be and the same is hereby adopted as the Budget and Appropriations for this Public Library District for this fiscal year: and the sum of \$

<u>2,738,000</u> (Two million, seven hundred and thirty-eight thousand dollars) or as much thereof as may be authorized by law, is hereby appropriated for the purposes of the Crete Public Library District, as hereinafter specified for said fiscal year.

SECTION 3: That all unexpended balances of any item or items of any general appropriation in this Ordinance be expended in making up any insufficiency in any other item or items in the same general appropriation and for the same general purposes of any like appropriation made by this Ordinance.

**SECTION 4**: That the Board of Trustees of the Crete Public Library District established in the year 2000 a Special Reserve Fund to be accumulated from the unexpended balance from the proceeds received from the Library District taxes levied for the year 2000 and subsequent years, per 75 ILCS 16/40-50, and the Board of Trustees has adopted a plan or plans pursuant to the provisions

of 75 ILCS 16/40-5, et seq.

**SECTION 5:** That a certified copy of this Ordinance shall be filed with the Will County Clerk within thirty (30) days of its adoption, along with the attached estimate of revenues, per 35 ILCS 200/18-50.

**SECTION 6:** That the invalidity of any item or section of this Ordinance shall not affect the validity of the whole or part thereof.

**SECTION 7**: That all Ordinances or parts of Ordinances conflicting with any of the provisions of this Ordinance be and the same are hereby repealed.

**SECTION 8:** That this Ordinance shall be in full force and effect from and after passage, approval and publication as provided by law.
